Fisher & Paykel Healthcare wins Supreme Award at 2015 American Chamber of Commerce DHL Express Success & Innovation Awards - AmCham celebrates 50 years

The 16th annual AmCham DHL Express Success & Innovation Awards and AmCham's 50th Anniversary dinner were recently held at the Pullman Auckland Hotel, with Fisher & Paykel Healthcare winning the Supreme Award for trade with the United States.

AmCham was delighted to welcome Prime Minister the Rt Hon John Key, who attended the AmCham Awards dinner and presented the three exporter awards, as well as the Supreme Award.

Fisher & Paykel Healthcare has been developing innovative medical devices and systems for use in the field of sleep apnoea and respiratory acute care, adding value to patients, clinicians and healthcare organisations in New Zealand, North America and around the world. While the company employs 3,150 people in 36 countries, North America represents 43% of all products sold.

Chair of the Judging panel Stephen Titter said Fisher & Paykel Healthcare had consistently shown success and innovation in their products, which has seen their US business grow by 10% in the last year to US\$235m. "The company is investing \$10 to \$15 million in the current year and employing an additional 40 people as it moves to a direct US hospital distribution model. They focus on continually improving their products, serving more patient groups, extending their range of products and growing their international presence to deliver robust revenue growth," said Titter.

Tim Baxter, country manager DHL Express New Zealand, who announced the supreme winner, said "Fisher & Paykel Healthcare has established itself as one of New Zealand's most successful companies both in our local market and abroad. It is indicative of the opportunities that exist in the US market that Fisher & Paykel Healthcare has identified it as a key export area, and continues to work to develop this crucial trade lane. This is behaviour that DHL Express has also seen from other entrepreneurial and innovative exporters."

"This year was one of the toughest ever for the Awards' judges. Any one of the finalists could have been their category winner and all finalists should be recognized as winners for their outstanding achievements," said Stephen Titter.

Getting the Facts Straight: Access to Medicines and the TPP

It's ironic that today's life-saving medicines often resemble modern miracles while the biopharmaceutical companies that create them draw the ire of activist groups. This drama is playing out again in the context of the Trans-Pacific Partnership (TPP).

For example, a recent Vox piece entitled "Experts say Obama's Asian trade deal could drive up the cost of medicine" argues the TPP could deny access to medicines in developing countries, delay the introduction of inexpensive generics, and drive up the cost of medicines generally. [Read more.](#)

Successful negotiations to liberalise tariffs on IT products to benefit NZ exporters

Trade Minister Tim Groser has welcomed an agreement reached in Geneva to lower tariffs on over 200 IT related products, building on the WTO's 1996 Ministerial Declaration on Trade in Information Technology Products (ITA).

The agreement will lead to more than 20 WTO Members, including the European Union, progressively eliminating tariffs on a range of IT related products. The range of products covered has been expanded to reflect the significant technological developments that have occurred since the original deal was agreed in 1996. A timetable for eliminating tariffs is expected to be completed by December. [Read more.](#)

The Tripartite Economic Alliance - Auckland, Los Angeles and Guangzhou

The Tripartite Economic Alliance between sister-cities, Auckland (New Zealand), Los Angeles (USA) and Guangzhou (China), was signed in November 2014 for a three year term. [Click here to see video on the recent Summit and business delegation that went to Los Angeles.](#)

Examples of success stories from the summit include:

- ATEED's Screen Auckland production attraction specialists held discussions with Los Angeles and Guangzhou counterparts and identified potential production opportunities that could be worth tens of millions to Auckland' economy long term. Screen Auckland will work hard to secure these opportunities
- Digital Water met senior executives of the Los Angeles Department of Water and Power, and is planning a trial for its water meters in LA
- High-tech business incubator Astrolab progressed its plans to partner a business incubator in LA, providing a stepping stone for Auckland biotech companies to commercialise and expand in to LA
- Building ventilation equipment manufacturer HRV had discussions with a Chinese company which came to the summit to specifically meet HRV, and is now exploring expansion into China
- Flux Animation Studio found a potential new distributor, secured contract work with Disney, and discussed two potential contracts with a Canadian production company
- World-class furniture manufacturer IQ Commercial estimates its revenue will increase 20 per cent, and its employee base grow by 7-10 per cent, directly due to joining the delegation.

Update on Review of Customs and Excise Act

In March of this year the New Zealand Customs Service released a Discussion Paper as the first stage of its Review of the Customs and Excise Act 1996. Since then, approximately 80 submissions have been received and a number of general and industry-specific workshops have been held as part of the consultation process. Customs is in the process of preparing a Paper for Cabinet for consideration in August/September.

Our understanding is that it is intended to introduce amending legislation in the first half of 2016 to enable a new Act to be implemented by the beginning of 2017. There will be an opportunity to make submissions to the relevant Select Committee once the Bill has been introduced. In addition to the primary statute, amendments will be required to the secondary legislation including Regulations, Operating Policy Statements and Customs Rules.

Airlines

United Airlines will be operating an all Dreamliner 787-9 fleet between the US and Australia. The new aircraft currently operates the Melbourne-Los Angeles route and will replace the Boeing 777 on routes from Sydney to San Francisco and Los Angeles from March 2016. The aircraft changes does mean that United First Class will not be offered; the United 787-9's are configured as Business (48 seats) 63 Economy Plus and 204 Economy Class seats.

Virgin Atlantic will return to flying **twice a day** from **London Heathrow to LAX** from 25th October. The second flight will leave LHR at 12.20hrs and arrive in California at 15.50hrs same day. And while in LAX, there's a beautiful new Virgin Clubhouse to enjoy. Virgin also flies daily from Heathrow to Las Vegas. **Air New Zealand and Virgin** offer very competitive fares to London in combination with each other.

In a review of airline amenity kits **Delta Airlines** lead the path for US airlines. The case is entirely black, save for the red Tumi logo on the front. At a time when our regional airlines are cutting back on the quality of their amenity packs its good to see some standards are being raised.

LAN Airlines of Chile and TAM of Brazil are one pan-South America airline nowadays and the final phase of the merge is the new brand name which is to be **LATAM**.

Star Alliance carrier **Air China (CA)** begins operations between Auckland and Beijing on 10 December. The airline will code-share on the route with Air New Zealand. **Air China** shouldn't be confused with **China Airlines (CI)**, the airline of Taiwan which also operates between both Auckland and Christchurch to Taipei, Taiwan. **China Southern (CZ)** will also start non-stop flights between their hub in Guangzhou to Christchurch later this year. All of these airlines fly onward to various US destinations from their Chinese hubs and most have some excellent fares available.

Business travellers applying for a new **APEC Business Travel Card** from September 1 2015 will find their precious plastic valid for five years – boosted from a maximum of three years at present. APEC Cards serve to avoid a country's usual visa requirements for business travellers, while also providing access to fast track APEC passport control lanes at major airports to avoid the often-lengthy queues. It's especially useful for business travellers visiting China and Russia – both of which ordinarily have strict visa requirements – but can also come in handy with the likes of Hong Kong, Japan, Singapore and Thailand to shorten your wait at passport control. Canada and the USA too provide fast track immigration for APEC Card holders, but while enforcing normal visa requirements.

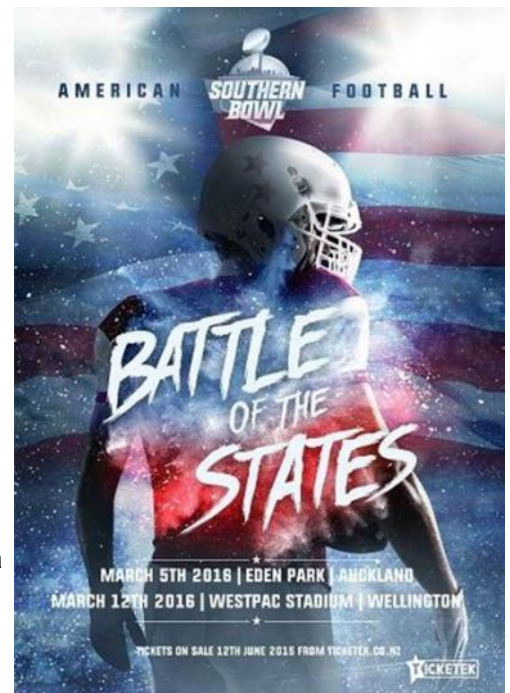

TEXAS – IT'S NOT JUST A STATE OF MIND.

Welcome to Texas, the friendly state...it's a whole other country. Don't mess with Texas! Everything's bigger in Texas!!! Howdy y'all,

These are some of the slogans New Zealanders will hear as they land at Air New Zealand's newest destination in the US—Houston, Texas. Many Kiwis are under the misconception that Texas is an unsophisticated state in the middle of the US that is full of cowboys, televangelists, tumbleweeds, rattle snakes and dare we say it, guns. Rather, Texas is actually home to the 14th largest economy in the world and a central US business hub. As Texas lawyers with our original office in Houston, we'd be remiss to lose this opportunity to extol the virtues of our home state and let y'all in on the Texas-sized opportunities for Kiwi businesses there. So we thought we'd write a fun editorial piece about our home state for your enjoyment.

Let's start by looking at our hometown of Houston. With direct flights from Auckland starting in mid December 2015 on Air New Zealand. Houston is the juggernaut of Texas cities, the fourth largest city in the US, and the world capital of the energy industry. However the Houston itself is much more than just oil and gas. Twenty-six Fortune 500 companies have their headquarters located in Houston, with only New York City outshining it (Texas in general has 54 Fortune 500 companies headquartered throughout the state).

Houston also is home to the world's largest medical centre, with over 21 hospitals and 33 other medical related institutions. The medical industry sector is one of many in Houston in which we believe Kiwi companies could thrive, as New Zealand is renowned for its ingenious medical technology and related software production.

Houston is also home to the largest port in the state, ranked first in the US in foreign tonnage received and the gateway to the US Gulf Coast. With continual labour problems striking the West Coast ports, the Port of Houston becomes more attractive when delivery is time sensitive.

From a higher level perspective Texas in general is a hub of several industries that fit well with New Zealand's business portfolio.

In particular, the Texas technology sector is particularly strong, but often overlooked in favour of its older brother out in Silicon Valley. To start with, the semiconductor was invented in Texas. Texas is also home to Dell Computers in Austin and has multiple large tech manufacturing plants throughout the Austin area (Motorola, AMD...to mention a few). In fact, Texas is home to over 17,600 technology firms. Dallas, the second largest city in Texas and the largest metropolitan area, is home to the Richardson corridor, where companies focus on intellectual property development and ownership.

Kiwi agricultural businesses should also look to the Texas market for opportunities. Texas leads the nation in the number of farms and ranches located in its borders, with 1 in 7 workers employed in an agriculture-related job. The total market value of the agriculture sector is \$100 billion annually, focusing on cattle, cotton, dairy, corn, grain, vegetables, fresh fruit, eggs and poultry. Kiwi expertise in the agricultural sector would be well received in Texas.

From a general business perspective, Texas is an outstanding candidate for the location of your US subsidiary. Incorporation and business organization is particularly easy and low cost. Further there is no personal income tax and corporate taxes are between 0.95% and 0.5% of your gross profit margin with the first \$1.08 million tax free (beating Delaware and California by a long shot). Cost of labour is particularly low with a host of well qualified highly educated workers waiting for job opportunities. In terms of labour costs, the average salary of a manager (office/general operations) is \$52,206 USD, and an administrative assistant's average salary is \$35,959 USD. Cost of living and real estate/leases are particularly affordable in most metropolitan areas in Texas. Finally and very importantly, Texas' central location makes it an excellent location from which you can service the rest of the country. In short, you would be wise to take a very close look at Texas as the home for your US subsidiary.

Finally, from a legal perspective, Texas is one of the most business friendly states in the US. Texas business and corporate law is well developed, with superb protection provided to corporate managers/directors and shields businesses from tort liability and high damage awards. Finally, the state and federal courts are well suited to handle sophisticated business and intellectual property disputes.

Kiwis and Texans share certain affinities for innovation, hands-on approaches to life, a love of family, and that famous can-do spirit and fierce independence. We believe that with Texas becoming more available to Kiwis, these affinities will lend themselves to a close business relationship between the great country of New Zealand and the great State of Texas.

We leave you with this quote that we feel depicts our home state quite well:

"There's a vastness here and I believe that the people who are born here breathe that vastness into their soul. They dream big dreams and think big thoughts, because there is nothing to hem them in."
